A. RANGE RULES

- 1) NO ALCOHOL is allowed during shooting. MOSGC reserves the right to remove any individual from the premises who appears to be intoxicated.
- 2) Always keep your firearm pointed in a safe direction and treat *every* gun as if it were loaded.
- 3) *Hearing and eye* protection are required at all times on trap fields.
- 4) Load your firearm at the *firing* station only, and unload it before moving to another station.
- 5) Keep the firearm unloaded and the action open when carrying it on club grounds.
- 6) In the event of a misfire, check that the barrel of your firearm is clear before reloading.
- 7) Unload your firearm and keep the muzzle pointed away from the trap house when it is occupied.
- 8) Only 12 gauge or smaller gauge shotguns are permitted on the range.
- 9) 1 1/8 oz. of lead is the maximum load permitted.
- 10) 7-1/2 shot is the maximum size shot permitted. (Acceptable sizes are 7-1/2, 8, 8-1/2, 9)
- 11) Do not discard misfired shells on the ground.
- 12) Do not shoot birds. Do not shoot targets called by other shooters without their permission.
- 13) Never load more than one shell in your gun unless shooting doubles or continental.
- 14) Pick up your empty shells. Please help keep our premises clean and safe.
- 15) NO HORSEPLAY! FIREARMS CAN KILL! TREAT THEM WITH DEADLY SERIOUSNESS!

B. AFFIRMATION OF RIGHT TO LAWFULLY POSSES A FIREARM

I certify that I am not prohibited under any federal, county or state law from possessing a firearm.

C. LIABILITY WAIVER (responsibility for accidents and injury)

I understand that gun handling and shooting are potentially hazardous, and misuse can result in serious injury or death. I, for myself, for my minor children, and my heirs, successors, executors, and subrogees, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS the Moose Old Skagit Gun Club, SPC, Inc., its directors, officers, agents, employees, shareholders, and membership, to the maximum extent allowed by law, from and against any and all claims, actions, causes, liabilities, suits, and expenses (including legal fees), which are related to, arise out of, or are in any way connected with my use of the premises of the Moose Old Skagit Gun Club, SPC, Inc. Range, including, but not limited to, negligence of any kind or nature, whether foreseen or unforeseen, and irrespective of whether such injuries, losses or damages were caused by the negligence of other guests/invitees, third parties, or from some other cause.

By signing this I am indicating that I have carefully read and understood this agreement and that I agree to abide by the range rules and the terms and conditions set forth. . . If minor children will be shooting, a separate "Range Use Agreement" must be signed by the parent or guardian for each minor child on the premises.
